**TITLE:** Resolution No. 2022-51: Amending City Council Policy A-2 Relating

to the Process for Appointment to a Board or Commission

### ABSTRACT:

City Council Policy A-2 (Boards, Commissions and Committees) prescribes the rules, guidelines, and ideals that govern Newport Beach's boards, commissions and committees, and can be amended by the City Council, as needed, through the adoption of a resolution. Resolution No. 2022-51 proposes to amend City Council Policy A-2 to discourage the appointment of persons who: (1) in their professional capacity supervise or are supervised by another member of the same Board or Commission, or (2) are a member of the same family as another member of the same board or commission.

### **RECOMMENDATION:**

- a) Determine this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Sections 15060(c)(2) and 15060(c)(3) of the CEQA Guidelines because this action will not result in a physical change to the environment, directly or indirectly; and
- b) Adopt Resolution No. 2022-51, A Resolution of the City Council of the City of Newport Beach, California, Amending City Council Policy A-2 (Boards, Commissions and Committees) Relating to the Process for Appointment to a Board or Commission.

# **DISCUSSION**:

At the July 12, 2022, City Council meeting, a majority of the City Council requested that City staff bring back a proposed amendment to Council Policy A-2 so that the City Council could consider amending the Council policy to discourage the appointment of persons who: (1) in their professional capacity supervise or are supervised by another member of the same Board or Commission, or (2) are a member of the same family as another member of the same Board or Commission. This proposed modification is designed to help ensure diversity of opinions and to avoid the appearance of a conflict. The proposed amendment to City Council Policy A-2 is reflected in Exhibit 1 to Resolution No. 2022-51.
