A. CITY-WIDE AND HUMAN RESOURCES MATTERS – Natalie Asato, Senior Human Resources Analyst

Senior Human Resources Analyst Asato reported:

- Human Resources currently has an open promotional recruitment for the Human Resources Specialist position
- During the month of April, a total of 180 City employees participated in the Step-Up Challenge presented by the City's HEAL Committee; this was a walking challenge where employees competed on teams for the highest number of steps each week
- Water Conservation Coordinator Shane Burckle retired on May 2 with 25 years of service
- Employee Training Opportunities:
 - Unlocking All 34 Strengths/Clifton Strengths 2.0 will be held on May 8
 - Senior Human Resources Analyst Maritza Leon-Mis will be attending the Tyler Munis Connect Conference from May 11 through May 14
- Open Recruitments
 - Full Time: Civil Engineer Plan Check, Fiscal Clerk, Maintenance Worker I/II, Management Fellow, Police Community Services Officer FT/PT, Police Officer – Lateral, Police Officer – Recruit & Academy Graduate/Academy Enrolled
 - Part Time: Assistant Recreation Coordinator, Intern, Maintenance Aide, Police Cadet, Senior Recreation Leader

B. FIRE DEPARTMENT MATTERS – Chad Spiker, Fire Staff Captain

- One of the lifeguard boats is in the initial planning phase for refurbishment
- Season lifeguard recertification classes are ongoing

- 12 candidates for the firefighter and firefighter paramedic recruitment have been selected to move forward to the background phase
- The Newport Beach Fire Department (NBFD) participated in the annual city-wide Emergency Operations Center (EOC) drill
- The Newport Beach International Boat Show took place this past weekend and our fire prevention division worked with event organizers to ensure emergency responders had clear access; there was one small fire on a boat show vessel and fire personnel were able to quickly extinguish the fire
- The Orange County Marathon took place on May 4; the NBFD upstaffed two additional paramedic ambulances, 10 fire cadets and the duty battalion chief was part of the event command staff
- Department-wide training was recently completed on a new process for communicating during structure fires; now two frequencies are utilized on all structure fires which will improve radio traffic and allow the incident commander to have clear contact with dispatch and supervisors during fires
- NBFD has started the annual wildland fire training and is preparing for the upcoming fire season

Vice Chair Moore inquired about the intention behind the county-wide frequency change; Captain Spiker clarified that it was not for improving response times, but rather to enhance on-scene communications by allowing incident commanders to communicate more effectively with dispatchers and supervisors.

Board Member Wood commended the Newport Beach Fire Department on their wildland wildfire mitigation video series; when asked about the scenario for the EOC drill, Captain Spiker revealed that it was based on a 7.8 magnitude earthquake on the San Andreas fault.

C. POLICE DEPARTMENT MATTERS – Jonathan Stafford, Deputy Director of Police Services

Deputy Director of Police Services Stafford reported:

- A promotion and swearing-in ceremony was held on April 28, Police Chief Miner and Jennifer Manzella were promoted and one lateral, two dispatchers and two community services officers (CSO) were sworn in
- The Police Appreciation Luncheon was held on April 11 at the Pendry Hotel

- The Newport Beach Police Department (NBPD) received their first BRINC responder drone last week and are preparing to commence operational flights; NBPD also has a loaner Lemur 2 tactical drone
- Hiring/Training Update
 - One lateral police officer has begun employment
 - o One part-time dispatcher has begun employment
 - Four recruits graduated from the sheriff's academy and are in the Field Training Officer (FTO) program
 - Three recruits are in the Orange County Sheriff's Academy (OCSA)
 - Two recruits have begun employment and are waiting to start the academy
 - o Eight officers, including recruits, are training in the FTO program
- In April 2025, Computer Automated Dispatch (CAD) events totaled 7,525, a decrease from 8,411 CAD events in April 2024.
- Year to Date Crime Statistics through April 30, 2025
 - Person Crimes are down 51 percent
 - Property Crimes are down 26 percent
 - Society Crimes are up 3.8 percent
 - o Total Crimes are down 21.8 percent
