#### LEVINE ACT

#### General comment

Although it is announced under "Meetings" on the City's <u>home page</u> and the agenda is linked to from the City's <u>online calendar</u> and its <u>Agendas & Minutes</u> page, it is not, oddly, posted on the <u>"Legistar"/"Granicus" page</u> where all City agendas and public notices have previously and consistently been posted, It could be missed by those who look only there.

## Item IV.A. PUBLIC EMPLOYMENT - PUBLIC EMPLOYEE APPOINTMENT

According to the agenda announcement, this item has been scheduled, pursuant to California Government Code section 54957 of the "Brown Act" (presumably Subsection 54957(b), to allow the Council to privately discuss the appointment of a City Manager and a City Clerk.

It seems worth remembering that the default expectation in California is for discussion of public business by legislative bodies such as a city council to take place in public, a position affimed and strengthened by <a href="Proposition 59">Proposition 59</a> in 2004, which added <a href="Section 3(b)">Section 3(b)</a> to Article 1 of the California Constitution, intended to guarantee that passages like Subsection 54957(b) that limit the public's right of access will be narrowly construed.

The problem here is that this exception to public discussion of the public's business exists solely to protect the privacy of the potential appointees, and since vacancies in the City Manager and City Clerk positions do not yet seem to have been posted by the Human Resources Department, it is not obvious there are any potential appointees to discuss. Indeed, at least with regard to the City Manager appointment, according to a recent City press release announcing the future retirement of the current City Manager, the Mayor is quoted as saying "the Newport Beach City Council will discuss the selection process for her successor during a closed session at its July 8 meeting."

The **process** by which a new City Manager or City Clerk will be selected, such as what qualifications will be sought and what salary will be offered (as opposed to the qualifications and merits of specific candidates) does not implicate any privacy considerations and is, therefore, not a legitimate topic for closed session discussion. It is public business that needs to be deliberated in public.

In other words, if there are candidates to discuss, this exception can be used. But if, as the press release says, this is about the selection process, it should be re-noticed for open session discussion.
