	Flamer is currently located in the teen section. The character in the book is 14 years old, so in 8th grade (middle school), which is the target audience for this book. I belive this book is AGE-INAPPROPRIATE, and needs to be moved to the adult section. I'm actually sickened that tax dollars have been spent on this, and that it's been here for this long, being shown to kids under 18. To begin, this book contains extremely disgusting language. Just one of the many examples, "Motherfucker! You fucking faggot. You're the faggot! You're the fudge-packing fairy cocksucking queer pansy faggot!" (p. 206-207). This book also contains several pornographic words AND pictures. A few examples, (p. 135) Picture of a boy laying in bed masturbating, (p.131) "We're busting a load into this bottle. (The picutre has a bottle and a boy pulling his pants down in front of another boy), (p.132) boy watching porn "those dicks are so big!", (p.133) boy naked sitting in front of a twatching porn talking aboutother people jerking off, (p.80) Naked boy in the shower, another boy kneeling right in front of him watching, and a scene $(cont - con p - a)$ .

Another concerning fact is that while the story is supposedly about bullying, there is a picture (p.306) of Aiden, the character, holding a knife to try and slit his wrist. The tag-line of the book is "this book saves lives!" but many conversations and pictures within actually give kids opposite ideas. Teens, especially, have increasingly high rates of depression and suicide. Giving them *visuals* of a 14 year old attempting to slit his wrist is very dangerous.

Overall, this book is very concerning and needs to be moved. The same exhausting talking points were given to me by Ms. Hartson regarding "seeking breadth and depth" and telling me all of the awards the book has received from Kirkus, School Library Journal, etc. I don't care if every major company gives this book 5 stars. I don't care how many libraries carry it. The book is (clearly) disgusting and should not be given to kids (people under 18). Newport Beach CAN and SHOULD do better by what they provide to children and teens. Perhaps it can be replaced by a cleaner, uplifting story. Ms. Hartson curiously states the book has "literary, artistic, and intellectual merit." I didn't know books for kids drinking cum, jerking off to porn, and slitting wrists were evidence of this. She states "materials are selected based on their content as a whole, not on selected excerpts," except the entire book is filled with this kind of stuff. Some argue that this book is about experiencing bullying, but certainly there are OTHER books that don't have this same language and pornographic pictures that can teach kids about bullying. Please work to provide better materials for kids, and move this book to the adult section. Thank you.

Dear Ms. Jenkins,

Thank you for taking the time to express your concern for the book "Flamer" written and illustrated by Mike Curato. We received your completed Request for Evaluation of Library Resources form and have evaluated the material based on the Newport Beach Public Library's *Collection Development Policy* (NBPL 2).

Collection development is based on specific criteria for selection and the title meets many of these criteria including community interest and demand; recommendations of reviews from professional journals and publications of national repute; reputation and qualification of author and publisher; literary, artistic, and intellectual merit; suitability of format; and suitability of subject and style to intended audience.

NBPL 2 states that "[m]aterials are selected based on their content as a whole, not on selected excerpts." "Flamer" is a coming-of-age story of 14-year-old Aiden Navarro as he navigates friendships, deals with bullies, and seeks acceptance.

The book received favorable reviews from School Library Journal, The Horn Book, Publisher's Weekly, The Bulletin of the Center for Children's Books, and starred reviews from Booklist and Kirkus Reviews indicating it is of particularly high value. These professional review sources profile the book as suitable for youth within ranges of 7<sup>th</sup> – 12<sup>th</sup> grade or ages 12 and older, while the Library's purchasing vendor recommends the title for ages 14 – 19. These criteria fit within the teen's collection parameters. This title is categorized as a teen graphic novel and is published by Henry Holt and Co. Books for Young Readers. The book received several accolades, including the 2021 Young Adult Lambda Literary Award, a School Library Journal 2020 Best Graphic Novel selection, and a Young Adult Library Services Association 2021 Great Graphic Novels for Teens selection. The Society of Children's Book Writers and Illustrators granted it a 2021 Golden Kite Award Honor – Illustrated Book for Older Readers. Twenty-five other public libraries in Orange County include this book in their teen book collections. The book's reputable reviews; esteemed awards; and peer library holdings serve as evidence to the literary, artistic, and intellectual merit of the item as well as the suitability of format for the teen graphic novel collection, which is intended for youth in 7<sup>th</sup> – 12<sup>th</sup> grades.

Furthermore, Accelerated Reader, a student reading achievement and assessment takes into account qualitative factors that include levels of meaning, structure, language conventionality, clarity, and knowledge demands. These elements determine an Interest Level. The Interest Level relates to content and age appropriateness and is based on students' abilities to comprehend the purpose and context of the text as a whole. The Interest Level for "Flamer" is rated for Upper Grades, or for students in  $9^{th} - 12^{th}$  grades. The Interest Level further reflects the suitability of subject and style to the intended audience for the teen graphic novel collection.

It is the intent of the *Collection Development Policy* that we seek to provide "breadth and depth" within our collections as well as various points of view. In addition, "use of library materials is an individual and private matter. Parents and caregivers have the primary responsibility to guide and direct the use of library materials by the minor children under their care and supervision." Patrons are free to either select or reject materials for themselves and not restrict the freedom of others to read or inquire. The title in question checks out often showing community interest and demand. This also reflects that tastes are individualized and subjective. As stated in NBPL 2, "It is the intent of the Board of Library Trustees ("Board") that the Newport Beach Public Library provides a contemporary, relevant collection of resources in order to meet the informational, educational and recreational needs of the entire community."

After careful consideration of the book, Library Policy, and professional evaluation, "Flamer" written and illustrated by Mike Curato will remain in the teen graphic novel book collection of the Newport Beach Public Library. Per the *Collection Development Policy*, "[i]f a patron disagrees with [this decision], the patron may appeal to the Board for final resolution" in accordance with the application for appeal and procedures attachment within the policy.

Again, we do appreciate your use of the Library and that you took the time to contact us with your concerns.
