Dear Chairman Harris,

My name is Hal Woods, and my wife Julia and I reside at 2919 Cliff Drive, directly above the subject property on the bluff next to the View Park.

We are strongly opposed to the proposed rooftop dining and bar use for the following reasons:

- **1. Noise and Public Safety Impacts:** Late night rooftop dining and alcohol service are incompatible with adjacent residential uses. This has already been demonstrated by the adjacent Whaler Bar, which has generated numerous police calls at 2:00 AM and beyond. A new rooftop bar would only exacerbate these late-night disturbances and compromise neighborhood safety.
- **2. Coastal View Protection:** The proposed rooftop structure will add height that intrudes upon the public's views of the coastline from the View Park. Under the California Coastal Act, protecting and maximizing public coastal views is a priority, and this project would undermine that mandate.
- **3. CEQA Considerations:** The project may have significant impacts related to noise, public safety, and visual resources that have not been adequately addressed. At minimum, a full environmental review is warranted before any approval is considered.

For these reasons, we respectfully request that the Commission deny this application in order to protect both the residential character of the neighborhood and the public's coastal resources.
