Assistant Fire Chief Justin Carr reported:

- Lifeguard staffing has dropped to winter levels with many seasonals returning to school
- Beach crowds have reduced
- Grant funding options are being explored to assist with the Junior Lifeguard Scholarship Program

Fire Operations

- Statistics
 - Fires: 16
 - Hazardous Conditions: 17
 - Emergency Medical Services (EMS)/Rescues: 764
 - Service Calls: 205
- Four firefighter paramedics completed the Academy and started on the floor on October 2, 2023
- Additional recruitment is in progress with hopes of hiring another five to nine firefighter paramedics
- With a recent captain resignation, a new captain will be promoted in November 2023
- There has been a decrease in wildfires due to the abnormal rain and overcast weather, more may be expected in the coming months due to the anticipated winds
- Newport Beach Fire Department was very pleased with the updated design concepts for Fire Station 1/Library

In reply to Vice Chair Herzog's inquiry regarding the Huntington Beach Air Show, Assistant Fire Chief Justin Carr stated that certain areas of the City do experience noise from the low-flying planes more than others but the Newport Beach Fire Department (NBFD) does not experience any problems from the planes aside from the occasional noise complaint.

In response to Chair Wood's question, Assistant Fire Chief Justin Carr shared that there is a fee for the Junior Lifeguard Program and the scholarship funding will help kids participate who cannot afford the fee.

C. POLICE DEPARTMENT MATTERS – Deputy Director of Police Services Jonathan Stafford

Deputy Director of Police Services Jonathan Stafford reported:

- Newport Beach Police Department held its Mobile Café on September 23, 2023, which was hosted by Peet's Coffee and Sprinkles at the Corona Del Mar Plaza
- A significant traffic collision on September 30, 2023, occurred at MacArthur and Bowsprit, leaving one party deceased and a second hospitalized
- Hiring/Training Update
 - One veteran police officer retiring in the next few weeks
 - One veteran police officer will move out of state
 - One lateral began work last week, with six other laterals in the background process

- Two recruits are on the books awaiting the start of the Academy, two more recruits will start in the next two weeks
- A police cadet, who is a former explorer, received a job offer and is in the final stages of the hiring process
- Several part-time community services officers have received full-time positions over the last three months due to resignations and promotions
- A crime scene investigator is in the final stages of hiring and should start within a month
- Six recruits are in Academy training
- One field training officer Academy graduate and one lateral are in training and progressing well
- For September 2023, there were 8,926 Computer Automated Dispatch (CAD) events, compared to 8,522 CAD events in September 2022
