My name is Jessica Wohl and I am a long-time resident of Dover Shores and lifetime resident of Newport Beach. I believe the location of this public aquatic center at Mariners Park is not appropriate in any way. I am confused and oppose this proposed location for the multiple reasons listed below:

- 1. A major love of Mariners Park is the GRASS and open area our community practices at for multiple sports, along with the playground and baseball fields which NHBA consistently uses. This park is absolutely packed on a daily basis with multiple activities. I would think that a location that is more open, under-utilized and in a community that does not have access to their own swimming pool would be better. There are many huge parks out there that barely anyone goes to and an aquatic center would be a great addition at those parks. This is definitely NOT one of them. Adding this center would result in a loss of existing recreational space that our community relies upon daily.

I hope you are well. My name is Sarah Pattermann and I am a resident of Dover Shores. I am writing to express strong concerns about the proposal to build the new public aquatic center at Mariners Park. While recognizing the value of aquatic facilities, I believe this location is not appropriate and that the project should instead be sited elsewhere. I ask that my concerns be considered seriously in the upcoming meetings and decision-making.

Below are some of the key issues from my perspective:

- Mariners Park is currently an important open and green space that offers room for many local kids to practice sports like football, baseball, soccer, tennis and more. It's also highly used for young children to have a place to play outside, instead of encouraging our youth to stay indoors and over utilize screens. Constructing a large aquatic facility will significantly reduce those amenities and change the character of the park.
- The infrastructure (roads, parking, ingress/egress) around Mariners Park is not designed for the increased traffic volume that would come with a swim complex. Residents will bear the brunt of added congestion and parking spillover.
- Nighttime or weekend events will increase noise, lighting, and disturbance to nearby homes. The quality of life for neighbors could be significantly impacted.
- Environmental risks must be considered: increased impervious surface, runoff of pool chemicals, heavy water usage, possible effects on local ecology, especially if any sensitive habitat is nearby.
- Cost and fiscal responsibility: the upfront construction is only part of the cost. The ongoing maintenance, staffing, heating, utilities, etc., may strain the city budget. If usage is less than projected, the burden may fall on taxpayers.
- Alternative sites have been discussed (e.g. OASIS Senior Center, Marina Park on the peninsula). Many of those may offer less disruptive or more suitable terrain, infrastructure, or visibility.
- Residents directly adjacent to Mariners Park deserve to have input, and I believe more comparative analysis should be done on all potential sites before finalizing one.

I would appreciate if the City could provide a detailed report comparing site alternatives, including traffic impact assessments, environmental impact studies, parking logistics, cost per site, and community feedback, ideally in advance of any votes or binding decisions.

Thank you for your time and attention to this matter. I care about our community, and believe in making smart, sustainable choices. I would be happy to attend any public meeting to speak further or share additional perspectives.

The initial proposal at Lower Castaways was set aside due to significant traffic concerns. Unfortunately, the new site at Mariners Park presents many of the same issues. As a longtime resident of the Mariners community, I am writing to strongly oppose the proposed aquatics center at Mariners Park. While I recognize the value of recreational facilities, this plan is deeply inappropriate for our neighborhood and would bring long-term negative impacts.

First and foremost, Mariners Park is one of the few remaining open green spaces available to families, children, and local schools. Installing a massive aquatics facility, along with expanded parking lots and new structures, would permanently reduce the park's natural character and compromise its current role as a community gathering space.

Second, the proposed designs call for significant increases in traffic and parking demand. Dear Newport Beach City Councilmembers,

As a 10+ year resident of Dover Shores, I am writing to strongly oppose the idea of placing a public pool in Mariners Park. Quite frankly, this is an awful *idea* that reflects poor planning and misplaced priorities.

- 1. **Mariners Park is already overburdened.** The park is heavily used for kids' sports practices, recreational leagues, and community events. It is, if anything, undersized for the demand it already serves. Taking away scarce open field space for a pool would be a direct blow to the residents and families who rely on the park as it is.
- 2. The pool is a solution in search of a problem. Spending \$50 million (roughly the estimate on the initial Castaways pool proposal) on a facility that few residents need or want is a classic boundoggle. Newport Beach already has an abundance of pools—community associations, apartments, private homes, clubs, and high schools all provide them. The lack of public demand from the people who live here makes this project unjustifiable.
- 3. **Council priorities appear misplaced.** From the outside, this feels less like a project to benefit residents and more like an attempt by this Council to build a monument to itself. Residents deserve investment in infrastructure and services that genuinely improve quality of life, not mayoral vanity projects.
- 4. The process has gone off the rails. The ad hoc committee behind this pool was formed to identify potential uses for *Lower Castaways Park*. When the pool idea proved unworkable there, instead of doing the job it was created for, the committee simply shopped the pool around to other locations—an exercise in stubbornly forcing a bad idea rather than solving the problem it was supposed to address.

In short, this project is unwanted, unnecessary, and wasteful. Mariners Park should be preserved and enhanced for its existing uses, not compromised to make way for an unneeded pool.

I urge you to abandon this ill-conceived proposal and instead focus on initiatives that provide real, tangible benefits to the residents who elected you.

I recently became aware of the city proposal to put an aquatic center (previously announced for Dover/PCH lower Castaways area) in Mariners Park.

Mariners Park is an important part of what makes Dover Shores such a vibrant neighborhood. From the open fields for games, practices, informal play or just running around, and to the playground, Mariners Park is a cornerstone of the local neighborhoods. Beyond the formal games and soccer practices, the fields at Mariners Park are also home to many informal team practices, pickup games, and just kids running around having fun.

The two tennis courts at Mariners Park are the only lit public tennis courts in the entire city, and a vital community resource along with the handball court/tennis wall nearby. During peak times (weekend mornings and late afternoon to evening on weekdays), these courts often have waits of over an hour with multiple groups waiting to access. The limited lessons available at Mariners Park are always filled almost immediately with a wait list.

I have seen the proposed designs and every one of them would destroy Mariners Park as it is and make it much worse and at an enormous cost to city taxpayers.

All of these would be detriments to the existing usage and character of the park:

- Remove open space to add numerous parking spaces for people coming from outside the neighborhood - BAD
- Remove the only lighted public tennis courts in the city that are heavily used already WORSE

Unfortunately, if the lower Castaways area is not viable for an aquatic center there may not be any suitable locations in west Newport unless the City can free up enough space from Corporation Yard to build there or purchase underused commercial/industrial space closer to the Santa Ana River.

I urge the City Council to preserve Mariners Park as the neighborhood recreational space it was designed to be. If an aquatic center is needed, please pursue locations that don't require destroying existing, well-used community assets. The Corporation Yard, underutilized commercial properties, or partnerships with Costa Mesa or the school district could provide solutions without sacrificing our neighborhood park.
