TITLE:	Resolution No. 2022-7: Changes and Additions to Street Sweeping Days for Portions of the Balboa Peninsula, Corona del Mar and West Newport

ABSTRACT:

New trash and recycling collection routes are being implemented to further improve efficiency and safety. Street sweeping route changes are also needed to coincide with the new trash and recycling collection routes. These changes will avoid conflicts, address parking conditions, and maintain street sweeping effectiveness. The areas affected are portions of the Balboa Peninsula and Corona del Mar. Staff is also recommending the establishment of parking restrictions for street sweeping purposes on a portion of Narcissus Avenue, and in the City's industrial area on West 16th Street, Production Place, Monrovia Avenue and Babcock Street.

RECOMMENDATION:

- a) Determine this action is exempt from the California Environmental Quality Act (CEQA) pursuant to Sections 15060(c)(2) and 15060(c)(3) of the CEQA Guidelines because this action will not result in a physical change to the environment, directly or indirectly; and
- b) Adopt Resolution No. 2022-7, A Resolution of the City Council of the City of Newport Beach, California, Establishing "No Parking" Restrictions on Designated Streets on Specific Days and Times to Improve Street Sweeping Effectiveness and Rescinding Resolution No. 2020-87.

DISCUSSION:

With the upcoming changes to the trash and recycling collection routes, staff has found it necessary to change the street sweeping days for portions of the Balboa Peninsula and Corona del Mar. The Tuesday street sweeping route between 21st Street and "G" Street (68 block segments) will change to Wednesday (Attachments A and B). The Wednesday street sweeping route for the flower streets north of Coast Highway in Corona del Mar (40 block segments) will change to Tuesday (Attachment C). These changes allow the City of Newport Beach (City) to maintain route efficiency and minimize the number of street sweepers on the road, while avoiding conflict with trash collection.

Approximately, one-third of the city is posted (and enforced) for no parking during street sweeping. This is primarily to ensure dense parking areas are kept clean. Other non-posted residential routes are being changed alongside the trash collection route changes. These streets, (i.e. the Port Streets) do not require a resolution as they are not posted. Those residents will be informed as part of the upcoming trash collection changes.

In addition to these changes, staff has been working with residents in Corona del Mar on a small, non-posted segment at the north end of the village. There is a concern with a lack of street sweeping because parked cars prevent the sweeping. The location is Narcissus Avenue, north of 5th Avenue, near the entrance to the Oasis Senior Center. Staff recommends adding parking restrictions on Mondays for Narcissus Avenue (Attachment C). Also, in the industrial area of West Newport, parked cars prevent street sweeping effectiveness and staff recommends adding parking restrictions on Tuesdays and Fridays for portions of West 16th Street, Production Place, Monrovia Avenue, and Babcock Street (Attachment D).

There is a city-wide master resolution which contains all of the posted street sweeping segments. The preferred method is to rescind the entire resolution, modify the selected street segments, and adopt a new resolution with all City street segments. Staff is recommending rescinding Resolution No. 2020-87 and adopting a new resolution for changes and additions to street sweeping days for portions of the Balboa Peninsula, Corona del Mar and West Newport. Attachments A-D show the limits of the proposed parking restrictions. Residents will be notified as part of the upcoming trash and recycling route changes information campaign. Route changes will be implemented in late January 2022 along with an enforcement grace period.

FISCAL IMPACT:

There is no fiscal impact related to this item.

ENVIRONMENTAL REVIEW:

Staff recommends the City Council find this action is not subject to the California Environmental Quality Act (CEQA) pursuant to Sections 15060(c)(2) (the activity will not result in a direct or reasonably foreseeable indirect physical change in the environment) and 15060(c)(3) (the activity is not a project as defined in Section 15378) of the CEQA Guidelines, California Code of Regulations, Title 14, Chapter 3, because it has no potential for resulting in physical change to the environment, directly or indirectly.
