I am a UCI graduate student, keeping our coastal traditions alive by restoring a classic sailboat in our beautiful harbor. I am so proud to call Newport Beach my port of call. I believe the city council values its boating community by implementing fair and transparent tideland policies.

The reason for contacting you is that I strongly disagree with the recent valuation of on-shore moorings conducted by Netzer & Associates.

Mr. Netzer's reconciliation of appraisals emphasizes (1) the Tidelands Market Rent Analysis, (2) the Comparable Rentals Approach, and (3) the Dry Storage Analysis.

The **Tidelands Market Rent Analysis is flawed** because it seeks to correlate the value of upland property to the on-shore mooring value. The fundamental flaw of this method is that upland property is four orders of magnitude more than the moorings. There is no way to accurately make such a correlation.

The **Comparable Rentals Approach is flawed** as pointed out on p.24 of the appraisal where I quote directly from Mr. Netzer, "...I did not uncover any other harbor or marina that provides on-shore moorings". No direct comparison exists yet Mr. Netzer uses the privately managed Lido Island Community Association as a comparison. The rates charged by LICA are one fourth the evaluation proposed by Netzer.

The **Dry Storage Analysis is flawed** since it fails to account for weathering that moored vessels undergo relative to dry storage. Dry storage and on-shore moorings cannot be of equal value for this reason.

The use of only three of the six conducted appraisals skews Mr. Netzer's valuation of on-shore moorings in favor of the most expensive analyses. **There is no mathematical calculation for how the \$20/ft appraisal was obtained.** Thus, I believe Mr. Netzer's valuation of \$20/ft is injudicious.

This topic will be discussed in today's Harbor Commission Meeting and I strongly recommend that the commission members reject the Netzger appraisal and continue with the CPI adjustment for on-shore moorings.

Thanks for reaching out.

This is a bit of a challenging situation for me as for professional reasons I need to remain completely neutral.

There may well be communication from other BYC leadership in the short-term indicating efforts being undertaken.

In the meantime, I can say without any bias that the message from the NMA published earlier today is somewhat incomplete.

An appraisal of the fair market rate for onshore moorings has recently been published and will be reviewed by the Harbor Commission.

Published in the appraisal is a fair market rate significantly higher than the rate being charged for onshore moorings today.

The best way to get involved is to show up at the Harbor Commission meeting tonight (Wednesday) at 5 pm in Council Chambers at City Hall and express your thoughts on the matter.

The review of the appraisal is not the first matter on the agenda and unfortunately I cannot predict with any accuracy how long the matters before it (two public hearings on dock reconfigurations and a review of the Harbor and Beaches Master Plan) but I imagine those three items will take at least 45 minutes.

To help formulate your thoughts, you may wish to consider the process by which any rate adjustments will be considered:

- As is required by law, the City engaged an appraiser to evaluate the fair market value of onshore moorings
- The appraiser's report is getting its first public hearing tonight (Wednesday) at the Harbor Commission meeting
- The public is welcomed and encouraged to contribute to that public hearing which will take place at 5 pm in Council Chambers

- Once having considered the appraiser's report, the Harbor Commission will formulate a recommendation to be sent to City Council. It may take more than one meeting for the Commission to come to agreement on a recommendation
- Once the Council receives the Commission's recommendation, it will decide what, if any rate adjustment should be adopted



I purchased the rights to a shore mooring on Balboa Island in 2019 at a cost of \$25,000 with the understanding that I would be paying a rental fee of about \$340 a year to the City of Newport Beach. It is unconscionable for the Harbor Commission to be considering a 10 to 15 fold increase in rental fee over a period of less than a year.

The recommended increase in rental fee totally ignores the acquisition cost paid at the time of acquiring a right to rent the mooring. The premise of the suggested increase would be justifiable if the practice of "selling" the rights to a rental had not been an accepted practice by the Harbor Commission over the past several decades.

What is being proposed is a non-starter.
