TITLE: Budget Amendment to Accept a Check from the Friends of the

Newport Beach Library and Appropriate Funds to the Library's Fiscal

Year 2018/2019 Maintenance and Operation Budget

ABSTRACT:

Staff requests approval of a budget amendment to accept a check from the Friends of the Newport Beach Library to enhance the Library collections and programs.

RECOMMENDATION:

- a) Determine that the action is exempt from the California Environmental Quality Act (CEQA) pursuant to Sections 15060(c)(2) and 15060(c)(3) of the CEQA Guidelines because it will not result in a physical change to the environment, directly or indirectly; and
- b) Approve Budget Amendment No. 19BA-004 to increase revenue estimates by \$175,000 in Account 0106052-511080 (Friends of the Library Donations) and to increase expenditure estimates by the same amount in Division 0106052 (Friends of the Library):

DISCUSSION:

A donation from the Friends of the Newport Beach Public Library in the amount of \$175,000 is intended to fund library materials and programs on the Library's Wish List for 2018/2019, which was approved by the Board of Library Trustees.

The Friends mission is to enhance the excellent services that the City already supports. This gift will augment the Library collections at all locations, in all formats and for all age groups. A portion of these funds will be used to purchase high-demand newly released titles. The funds will also sponsor programming for all ages such as Summer Reading, National Library Week, Young Adult programs and First Grade Class Visits.
