My wife and I both grew up in Newport and were able to move back 2 years ago. We live in Newport Shores and use the boardwalk four times a week.

Electric Bikes and other motorized modes of transport should not be allowed on the boardwalk. I feel the streets have adequate bikes lanes for these "motorized vehicles". Most go over the 8MPH speed limit and My guess is some pass us at 20mph. And to that, lots of people use these electric bikes for surfing with metal tubes protruding out next to the bike.
