Aviation Committee Members,

The General Aviation Improvement Program (GAIP) proposals have been scored by a panel of five impartial experts. It is recommended that the Aviation Committee and the City support the highest-ranking proposal in each of the three FBO Service categories.

The highest rank in the full-service FBO Northeast parcel is Clay Lacy Aviation with a total points of 407.

The highest ranked in the full-service FBO Northwest parcel is Atlantic Aviation with 475 points.

The highest ranked in the limited FBO is Jay's aircraft with 407 points.

The Ad Hoc Committee evaluated the proposals to determine if they complied with the city's Goals for the General Aviation Improvement Program.

Per the chart (titled Ad Hoc Committee Evaluation of Fixed Base Operator Proposals) the proposals submitted by Clay Lacy, Atlantic Aviation and Jay's Aircraft were found to align with the city's goals.

Monday July 27th Aviation Committee Question:

At the 6/26/19 BOS meeting Diane Dixon and several mayors argued against an FBO being allowed to have Customs and Border Patrol. The City of Newport Beach openly opposed it in writing and at the podium. Since then Covid-19 has brought heightened attention to airport security, stringent health screening, quarantine facility access, and tighter borders. Since 2016 the Trump administration has advocated for tightened border security. Having an FBO with a GAF is in open opposition to the Trump administrations efforts. Will the city again advocate against having international arrivals, regardless of whether JWA is a final destination? Border security, now more than ever, is to be done by the DHS (Department of Homeland Security) at facilities such as Brown Field, Ontario, LAX, Long Beach, Seattle, San Francisco, et al, where permanent and advanced methods are under the constant supervision of the DHS. Will the city insist that regardless of “destination” all private international arrivals are to be CBP inspected prior to arrival at JWA?
