I. CALL MEETING TO ORDER

Chair Diane Dixon called the meeting to order at 5 p.m.

II. ROLL CALL

Committee Members Blom, Braley, and Ray had excused absences.

III. APPROVAL OF MINUTES

Motion to approve the minutes of July 18, 2022, meeting as presented was made by Committee Member Cole and seconded by Committee Member Logan. The motion carried unanimously with Committee Members Johnson, Ray and Verdi abstaining.

IV. CHAIR'S ANNOUNCEMENTS

Chair Dixon discussed the Ad Hoc Committee effort that led to the Aviation Committee approving recommended elements of a proposed Fly Quiet / Fly Friendly program on December 20, 2020. The proposed program was forwarded to the County of Orange for consideration. The County and John Wayne Airport implemented the Fly Friendly program on August 17, 2022. It contains

almost all of the Ad Hoc Committee's recommendations including a voluntary restraint on nighttime operations.

The Orange County Register recently published an article about lead in the fuel of smaller aircraft. She recommended the Aviation Committee discuss the article's findings at the October or November 2022 meeting.

At the last Aviation Committee meeting, a letter from the City of Newport Beach to the County Board of Supervisors was distributed that expressed the City's opposition to any expansion of the commercial runway at John Wayne Airport (JWA). The City received responses from Supervisors Bartlett and Foley.

Chair Dixon referenced Gary Sherwin's recent column in *Stu News* and John Wayne Airport. She spoke with Mr. Sherwin and said he was not in support of airport expansion.

V. <u>CURRENT BUSINESS</u>

A. Oral Reports

1. Tara Finnigan, Assistant City Manager, will share updates from the City's government relations consultants Channon Hanna of Carpi & Clay and Cori Takkinen of Townsend & Associates.

Assistant City Manager Finnigan held her comments for later in the meeting.

2. Mel Beale, Airport Working Group, will provide an update on items related to the commercial airline noise mitigation workshop.

Mr. Beale shared that the workshop was held on July 19, 2022. The workshop was attended by the airlines and held via Zoom. Southwest, Alaska and United presented and shared the progress they have made on the targets suggested by the Airport Working Group. Southwest is actively working on the requested delay to 4,000-foot altitude for engaging the auto-throttle (AT), versus the current 3,000-foot activation. The 3,000-foot AT engagement negatively impacts communities south of Coast Highway with higher noise, and the 4,000-foot request would mitigate this. They will continue to talk about it internally with their safety committee and flight standards group. The original request to Alaska Airlines was to use the NADP-1 departure procedure and to throttle back power at about 1,200 feet. Alaska's flight operations department and crews are not currently qualified to use NADP-1, so they use NADP-2, which is a lower departure flight profile. A temporary request is to reduce the throttle in the same manner requested of United. Alaska is not sure if it can safely pull back the throttle on climb as much as United. Alaska offered to work with AWG to test the concept on its flight simulators, and if it is successful and safe, and shows significant noise reductions are possible, they will work to get it incorporated for JWA departures. United Airlines committed to a continuation of its internal review of the throttle reduction after cutback at 1,200 feet requested based on flight simulator testing. All three airlines were asked to report back to the workshop group at a planned meeting in mid-November on their willingness to move forward on these requests. Mr. Beale noted he will follow up with the three airlines periodically before November to get feedback on their progress. The airlines and the Airport Working Group also discussed timing on fleet updating, using newer planes that have quieter engines at JWA.

Committee Member Cole asked what the decibel reduction is for just the thrust reduction and Mr. Beale answered approximately 3.9 decibels per flight simulator tests.

Committee Member Johnson inquired if the reduction is for the whole flight path. Mr. Beale noted the 3.9 decibel reduction was achieved after 1,200 feet. Commissioner Member Johnson stated the decibel reduction and the newer planes are great but she expressed concern about pollution.

Committee Member Alston mentioned that Dennis Bress, a member of the public, submitted a comment that commercial departures are lower, faster and louder. She concurred with his assessment. Mr. Beale confirmed that Alaska Airlines flies consistently lower than the other airlines due to its use of NADP-2.

Assistant City Manager Finnigan confirmed the comment about altitude has come up several times in phone calls received at City Hall. Airport staff is going to conduct another altitude assessment.

Mr. Beale noted that if the airlines affirm their commitments at the November meeting then a public announcement will be published. He predicted there will be improvements from Alaska Airlines, and United and American Airlines will continue to evaluate and if deemed feasible, will introduce the reduced throttle departure.

Committee Member Alston inquired if there have been any publications about the adjustments the airlines have been making. Assistant City Manager Finnigan remarked the airlines have requested not to publicize the accomplishments until full implementation.

Shana Conzelman, a resident of Lido Island, inquired how the proposed testing compares to what was in place in prior years. She mentioned when higher faster was used, there was never a consistent issue with noise and repetitive take-offs.

Assistant City Manager Finnigan explained that higher faster was evaluated. The City requested that the air carriers use NADP-1 and the Aviation Committee suggested a departure procedure that restricts speed to a certain point offshore. The Airport Working Group is exploring that concept with the air carriers.

Committee Member Alston inquired about the older departure procedure. Committee Member Stranberg noted the FAA agreed with the pilots that the older departure is dangerous, especially if there was a loss of engine on departure. Committee Member Alston commented folks living on Balboa Island, the East Bluff and Irvine Terrace are experiencing a significant difference in noise from prior years.

Committee Member Khoury mentioned since the prior year, the average daily flights have increased by 10 and the prior year saw fewer flights due to the Covid-19 pandemic. The departures are one after the other and many are flying low, subjecting people to constant noise.

Jim Mosher explained that prior to 1993, the airport instructed pilots to cut back the power at 500 feet and that was deemed dangerous. That was changed to cut back the power at 800 feet or higher. He referenced Mr. Bress' handout, and noted Alaska is quieter in the comparison between Spirit and Frontier. The lower faster planes are quieter than the higher slower planes depending on which monitor they're near; he acknowledged the situation is more complicated.

B. Formation of a Communication and Education Ad Hoc Committee

1. Staff recommends disbanding the Communication Content and Educational Programming Ad Hoc Committees and forming a new, Communication and Education Ad Hoc Committee.

Chair Dixon noted the new Committee will be Committee Members Alston, Braley, Ray and Rubino.

Motion to disband the Communication Content and Educational Programing Ad Hoc Committees and approve the formation of a new Communication and Education Ad Hoc Committee was made by Committee Member Logan and seconded by Committee Member Khoury. The motion was unanimously approved.

Jim Mosher recommended the new Ad Hoc Committee conduct its meetings publicly because the Ad Hoc Committee is acting on its own and not as an advisory committee.

C. Aviation Committee 2022 Priorities – Progress Updates

1. Individual members or Ad Hoc Committees that have met or otherwise studied their respective priority will provide progress updates.

Assistant City Manager Finnigan requested Committee Member Cole provide an overview of his meeting with JWA. Committee Member Cole reported that staff from the Noise and Access Office has agreed to provide more detailed data about early turns over a period of a month. We should have that by the October meeting for both Class A and E aircraft. He also discussed single event data which can be provided from the City's dashboard.

Committee Board Member Stranberg reported on fleet updating and announced that Southwest Airlines invited him to meet on August 30. That type of relationship must be established between the City and all carriers. During January through May, there were no Southwest Max flights operating out of JWA. Starting in September and October, Southwest will have three of their 6:45 a.m. departures be Max's with a total of seven Max's departing by 10 a.m. In November and December, roughly 25 percent of Southwest's flights will be Max's. The Max-7 has not been certified by the FAA but they predict it will be certified by December. He met with JWA Airport Director Charlene Reynolds and she's supportive of the fleet upgrade strategy. It takes approximately six months to integrate new planes into the fleets.

Committee Member Logan mentioned the CEO of Boeing announced that they are producing 31 Max's per month. Committee Member Cole inquired about the difference in decibels between the Max's versus the existing aircraft. Committee Member Stranberg answered the difference is five to eight decibels.

Committee Member Rubino said he and Committee Member Ray put together a draft PowerPoint presentation that provides a high-level summary of the history of the settlement agreement, the effort of the Aviation Committee and City policy. The newly formed Ad Hoc Committee will meet and revise the presentation. Then the presentation will be presented and considered for adoption by the full Aviation Committee.

Assistant City Manager Finnigan added that the newly formed Ad Hoc Committee will help staff with content development. Chair Dixon recommended the presentation be made available to the community by the end of the year.

Committee Member Verdi stated in order to accomplish the City's goals, he and the City's federal lobbyist have been working on perfecting the process of how to submit items to the FAA. The focus is to develop and present proposed standards for the FAA's ombudsman program. The standards will hold the FAA more accountable for actively resolving complaints. Chair Dixon supported the effort. Committee Member Stranberg recommended working with other jurisdictions and presenting standards that are endorsed by other cities. Committee Member Alston suggested the City become more active in the Quiet Skies Caucus.

Committee Member Livingston reported within the past month the County of Orange announced an additive has been approved by the FAA which will eliminate the need for leaded fuel in aircraft. They predicted it will be at all airports within one to two years.

Mel Beale referenced the FAA Reauthorization Bill and mentioned proposals should be submitted soon after the elections. That way they can be placed on the January agenda. The community organization called NOISE is a national organization that focuses on aviation noise.

Shana Conzelman wanted to know why District 1 and District 2 positions are vacant. Chair Dixon remarked the positions are open for applications. Charles Klobe commented that District 7 has two representatives and encouraged reducing that to one representative.

Sue Dvorak asked if Michelle Steel, who is on the Transportation Committee in Washington DC, is helping the City and she also said she had a discussion with Supervisor Foley about installing a structure to house lead-free aviation fuel when it is made available.

Jim Mosher noted the new 737 Max planes have a high pitch whine. The airport's quarterly noise report indicates that Class A Max departures have decreased plane noise by four decibels but Class E Max departures are louder. Also based on the quarterly reports, the implementation of new technology planes overall has improved noise levels over the last four years.

Nancy Scarborough, board member of Stop Polluting Our Newport (SPON), announced that the annual SPON meeting will be held on September 24, 2022 from 10 a.m. to 12 p.m. at the Environmental Nature Center. The keynote speaker will be Airport Director Charlene Reynolds.

Assistant City Manager Finnigan announced the airport's quarterly noise meeting will be held on September 27, 2022 at 2 p.m. via Zoom.

VI. PUBLIC COMMENTS ON NON-AGENDA ITEMS AND ITEMS FOR FUTURE AGENDAS

Jim Mosher remarked there is an agreement with the City of Costa Mesa that a representative from the City of Costa Mesa be on the Aviation Committee. That provision was overlooked during the adoption of the enabling resolution by the City Council. Based on a Public Records Act Request he made to the airport, he discovered the airport is not operating with a variance that they are supposed to have from Caltrans to operate in the noise impact area. The official impact area is a small area around the golf course in Santa Ana Heights. There are some homes there that were eligible for an acoustic installation program and other mitigation measures. He recommended the Aviation Committee explore whether the airport has a variance, if it is current and what the airport is doing to prevent noise impacts on nearby residents.

Board Member Johnson restated she found the Gary Sherwin article in *Stu News* about airport expansion concerning. Chair Dixon remarked that she spoke to Mr. Sherwin and he did not intend to conflict with City policy. He felt the airport is important economically.

Board Member Alston strongly disagreed with the notion that a longer runway will result in quieter planes.

Committee Board Member Johnson noticed that Policy A-17 only mentions commercial aircraft and the protections from general aviation should be included. City Attorney Harp responded that Council Policy A-17 primarily relates to commercial aircraft because that is what is covered by the settlement agreement.

ABSTRACT:

Over the course of several meetings, the Communication and Education Ad Hoc Committee developed an educational presentation for Aviation Committee members to utilize when presenting on aviation-related matters at homeowner, service organization and other community meetings.

RECOMMENDATION:

DISCUSSION:

The Communication and Education Ad Hoc Committee is comprised of Aviation Committee Members Nancy Alston, Elizabeth Braley, Sharon Ray and Ron Rubino. The Ad Hoc met with City staff several times over the past month to discuss and plan for content for staff to share via City communication channels and to develop an educational presentation on the City's and Aviation Committee's aviation-related efforts.

About the 1985 Settlement Agreement

- Agreement between the City, County, Airport Working Group and Stop Polluting our Newport (SPON)
- Pertains to commercial air traffic
- Pre-dated the Airport Noise and Capacity Act of 1990
- · Agreement is "grandfathered"

Scope of the 1985 JWA Settlement Agreement

- Established a night-time curfew for commercial planes arrivals and departures
- Limited Average Daily Departures
- Limited service to 8.4 million annual passengers (MAP)
- · Limited terminal size, loading bridges and parking spaces
- Had a 20-year term

JWA Settlement Agreement - 2003 Amendment

- Increased number of "Class A" ADDs to 85
- Increased MAP to 10.8
- Increased loading bridges from 14 to 20
- · Removed limitations on terminal size and parking
- Extended term until 2015
- Required curfew hours and regulations to remain in effect until 12/31/20

2014 Settlement Amendment - Today's Agreement

- 1. Limited "Class A" ADDs (the noisiest flights)
 - Maintained 85 Class A ADDs through 12/31/20
 - Increased to 95 Class A ADDs from 1/1/21 through 12/31/30
- 2. Changed the Million Annual Passenger Limits (aka, the MAP Cap)
 - Phase 1: 10.8 MAP through 12/31/20
 - Phase 2: 11.8 MAP from 1/1/21 through 12/21/25
 - Phase 3: Either 12.2 or 12.5 MAP from 1/1/26 through 12/31/30
- 3. Facility Restraints
 - Maintained limit on loading bridges until 12/30/20
- 4. The agreement's restrictions will continue until 12/31/30
- 5. The curfew exemption will continue until at least 12/31/35

JWA Settlement Agreement – Strengths & Weaknesses

Strengths

- JWA has the most stringent agreement in U.S. limiting airport activity and growth.
 There will never be another like it.
- Provides for the nighttime curfew and other protections that help preserve the quality of life in Newport Beach.

Weaknesses

- Must be re-negotiated approximately every 15 years and each negotiation involves compromise.
- General Aviation is referenced but not included in the Settlement Agreement.
- Orange County is not required to maintain the agreement if terms cannot be reached.

Potential Renegotiation Points

- Increases in Average Daily Departures or Million Annual Passengers
- Maintaining the curfew

About the City's Aviation Committee

- Comprised of two City Council Members and 13 citizen volunteers
- Sets an annual list of priorities
- Meets the third Monday of the month at 5 p.m.

Aviation Committee Initiatives

- Quieter departures commercial
- Quieter general aviation departures Fly Friendly
- Commercial fleet transition encouraging newer, quieter planes
- Government relations federal, county, Federal Aviation Administration
- Community outreach and education
- Monitoring development of general aviation improvement program

Fly Friendly Program

- Educates GA jet operators about ways to reduce their noise at and around the airport, as measured by JWA's Noise Monitoring Stations.
- Encourages GA jet operators to voluntarily adopt more sustainable aviation practices and technologies that help contribute towards reducing pollution.
- Scores these voluntary actions and rewards participants with the top 3 highest scores in each tier through an annual recognition initiative.

General Aviation Improvement Program

- Once started, construction will take 7 years to complete
- Maintains two full-service fixed base operators (FBO) and one limitedservice FBO
- Created yellow and green areas to preserve majority of space available for smaller aircraft
- Changed the general aviation rent structure at JWA

The results are as follows: 1) through October, there will be 14 Max departures out of JWA, representing 26% of the departures.
